Since its inception, FSGA's membership year has run from April 1 to March 31. To simplify this process, we are aligning our membership cycle with the calendar year. Starting this year, memberships will now begin on January 1 and end on December 31, making it easier to remember and manage.

Membership renewals for 2025 will open on December 1, 2024, and we encourage everyone to renew by January 2025. As a gesture of appreciation, members who renew by January will receive a complimentary three-hour training session titled Ethics and the Law: Series II—an in-depth exploration of civil rights and ethical dilemmas. This training will be held on February 6, 2025, at the FSU Alumni Center (Rendina Room), located at 1030 W. Tennessee St. in Tallahassee. Members can attend in person or virtually. This session, valued at \$100, will be offered free to those who renew by this date, and eligible members will receive a coupon for access.

IMPORTANT UPDATE FOR MEMBERS: CHANGES TO THE CE BROKER SYSTEM

As many of you are aware, there have been recent changes to the CE Broker system. As part of these updates, the required Continuing Education (CE) hours for guardians have increased from 16 to 30, with specific requirements in the following areas:

- 2 hours in Fiduciary Responsibility
- 2 hours in Professional Ethics
- 1 hour in Advance Directives
- 3 hours in Abuse, Neglect, and Exploitation
- 4 hours in Guardianship Law

New CE Broker reporting numbers have been issued to all guardians. If you have not yet received your new number, you can look it up on the OPPG website.



Trouble Accessing Your New CE Broker Account?

If you're having difficulty accessing your new CE Broker account, we recommend contacting OPPG directly and requesting that they resend the CE Broker welcome email. This email provides the portal access to your new account.

Missing or Misallocated Credits?

Some members have reported missing credits or credits that have been placed in the wrong categories. If you experience this issue, please reach out to the provider of your course to resolve it. During the migration, some data may have been lost, which could explain these discrepancies.

Multiple Accounts?

If you have multiple accounts in the system, please contact OPPG for guidance on how to consolidate or address the issue.

New! FSGA CEU Diary

To assist our members with tracking Continuing Education, FSGA has created a CEU diary, which is available as a membership benefit. This tool allows you to log the CEU courses you have completed, serving as a backup to the CE Broker system. It also provides a convenient way to ensure that your courses have been uploaded correctly and into the appropriate categories. Additionally, the CEU diary generates a clean, printable report in case you need to provide verification of your CEUs to local authorities.

One of the highlights of the event was the Broward County Chapter's **generous giveaways for indigent wards**, showcasing the community's commitment to improving lives. In addition, the chapter has already approved requests for an additional \$4,250 in gift cards. These funds will soon be distributed to guardians who submitted the necessary forms, further supporting the needs of the community's most vulnerable members.
